Announcement pursuant to Section 125, sentence 1, and Section 62(3), sentence 2, of the German Transformation Act (UmwG)

VOLKSWAGEN AKTIENGESELLSCHAFT (VW AG), with its registered place of business in Wolfsburg and entered in the Braunschweig register of companies under HRB 100484, hereby announces that AUDI Aktiengesellschaft (AUDI AG), with its registered place of business in Ingolstadt and entered in the Ingolstadt register of companies under HRB 1, as the transferring entity, and VW AG, as the acquiring entity, intend, by means of division for purposes of absorption (Section 123(2), item 1 of the German Transformation Act (UmwG)), to transfer each of the 100% shareholdings in

- Automobili Lamborghini S.p.A. with its registered place of business in Sant'Agata Bolognese, Italy, entered in the Registro Imprese di Bologna under BO-006-30107,
- Audi Luxemburg S.A. with its registered place of business in Strassen, Luxembourg, entered in the Registre de Commerce de Luxembourg under B 201275

to VW AG.

As the entire share capital of the transferring entity, AUDI AG, is held by the acquiring entity, VW AG, a resolution of a General Meeting of VW AG is, pursuant to Section 125, sentence 1, and Section 62(1) UmwG, not necessary unless shareholders of VW AG whose combined interests constitute at least one twentieth of the share capital of VW AG demand that a General Meeting be called at which a resolution will be passed concerning approval of the division.

The shareholders are hereby expressly informed of their right to demand that a General Meeting be called at which a resolution will be passed concerning approval of the division. A call for a General Meeting can only be considered if it is submitted to VW AG within one month of the publication of this announcement and is accompanied by proof of shareholding.
